1. WELCOME AND APOLOGIES

JA welcomed everyone present and noted there were no apologies. A total of 11 proxy votes had been received.

2. MINUTES OF THE PREVIOUS MEETING

JA passed a motion to accept the minutes from the previous IGM held on 6 March 2017. JA/JB All agreed. Motion 2017/05 was carried.

3. MATTERS ARISING FROM THE MINUTES

There were no matters arising.

4. PRESIDENT'S REPORT

JA gave a brief overview of her report which had been tabled and outlined the PGSA objectives:

- act as the voice of postgraduate students at Victoria by representing them on university boards and committees
- promote excellence through the Victorias Awards, Research Excellence Awards, 3 Minute Thesis Competition and Academic Conference Grants
- create a postgraduate community through hosting events such as the Quiz night, Tuesday Chats, First Friday breakfasts and writing workshops.

PGSA membership at 25 September 2017 was 1225. Two membership drives were held each year in March and September/ October with prizes to be won for signing up before 31st October 2017.

The PGSA Academic Conference Grants were made possible by funding from the Vice-Provost (Research) Kate McGrath and provided funding for the conference fees of PGSA members attending an international conference. The PGSA represents postgraduate students on key Boards and Committees at Victoria University, at both the Faculty and University level. The PGSA has student reps on 26 university boards and committees, with current vacancies on the Faculty of Education Academic Committee and FoE Learning & Teaching Committee. JA thanked all those reps who had contributed to the postgraduate community through service on a University Board or Committee.

The PGSA submitted on the Maori and Pasifika Interventions Review in August 2017. After wide consultation, the Executive found that there was insufficient information available at the school level for postgraduate services for Maori and Pasifika services. The PGSA commended the Maori Learning Advisor role at Student Learning Service, as well as the Pasifika Postgraduate Network run out of Te Putahi Atawhai, as exemplary programmes helping postgraduate students with their unique needs.

The PGSA submitted on the Accommodation Review in June 2017. Again after wide consultation, the PGSA contributed to a joint submission with VUWSA which outlined the detrimental effects that the disestablishment of Uni Hall would have on postgraduate, and particularly international postgraduate students and their families. Following the submissions and a second proposal from the review committee, any decision on Uni Hall was delayed, and students were no longer faced with the imminent end of their access to university accommodation.

The PGSA held successful events during 2017 which had been outlined and these would continue during 2018. Upcoming events were overviewed.

5. TREASURERS REPORT

The Treasurer's Report was tabled. RS outlined the main income and expenses. RH moved to accept the Treasurer's Report dated 30th September 2017. RH/SS All agreed. Motion 2017/07 was carried.



6. PGSA CONSTITUTION CHANGES

The proposed changes to the PGSA Constitution had been tabled and had been made to tidy up the Constitution in terms of consistency in numerals/words. JA spoke to the rationale to amend the substantive changes:

Clause 7.5 - removed "the executive may borrow funds" as this was irrelevant.

Clause 7.6 – removed as it didn't make sense to only allow policies and procedures that expanded on the rules in the Constitution.

Clause 11.9.2 – removed the clause about executive members vacating their position if they die.

The issue of consistency in numerals/words was raised as some had been missed. This would be rectified during the updating process.

JA moved to accept the Constitution changes. JA/AR All agreed. Motion 2017/08 was carried.
